growing health is... impacting our youngest patients

REACH OUT AND READ

What happens during the first few years of life for a child significantly sets the stage for their future. An innovative, yet simple model of "prescribing books" to our youngest of patients, a national program known as Reach Out and Read, gives young children a foundation for success by incorporating language-rich interactions into pediatric care and fosters the opportunity for families to read aloud, together.

The heart of Reach Out and Read is in the routine pediatric check-up period for children ages 6 months to 5 years old, when doctors, nurse practitioners and physician assistants encourage families to read books together with their young children.

2018 was the 18th anniversary for the Reach Out and Read affiliation with Neighborhood Health Center, run by long-time pediatric nurse practitioner and regional medical director since the program's inception, Tricia Kirst.

In 2018, Neighborhood Health Center's Reach Out and Read program has:

Provided nearly 5,000 new books

to pediatric patients (newborn to age 5)

25,000+ books

provided since the Health Center's affiliation began 19 years ago.

NHC pediatric nurse practitioner and Reach Out and Read Western New York pediatric care provider, Tricia Kirst, PNP, shares a book with a young patient during a well-child visit.

"The main takeaway is to note that Reach Out and Read is not just another book giveaway, rather a pediatric early intervention for parenting education and support," said Tricia.

Research tells us that interactions between parents/caregivers and children right from infancy is critically important to a child's healthy development. Sharing books is a simple and effective way of stimulating engagement. Talking about the story or the pictures while cuddled in front of a book makes a young child feel secure and loved, while the parent(s) feel that he/she is doing a good job.

While Neighborhood Health Center's Reach Out and Read program prides itself on providing books that are developmentally, culturally and age appropriate, this model shows us just how the simple act of "prescribing a book" at a patient visit can significantly impact a child's future through stimulation and early cognitive development.

What's on the horizon for Neighborhood Health Center's Reach Out and Read program in 2019? An expanded Prescription for Literacy program to add prenatal book enrichment opportunities during a pregnant woman's visit — because it's never too soon to connect with your child through reading.

Special projects and innovative approaches to healthcare sets the Health Center apart from your "typical doctor's office." Neighborhood Health Center not only helps patients focus on prevention and treatment of illnesses and diseases; but through critical partnerships and integrated care teams, the Health Center is able to provide holistic services that address body, mind and socioeconomic circumstances.


